


Octavia Brown Charles E. Jordan High School

The history of Tracking




"...the Hampton-Tuskegee model [that]



Social Reinforcement

"By the beginning of twelfth grade, 62 percent of Black students and 63 percent of Hispanic students were eligible to take an advanced math course, but only 23 percent of those eligible Black students and 25 percent of those eligible Hispanic students actually took an advanced math course"(Dania, Darity 8).

Detracking in High School

"If Black students were selected for AIG Math in proportion to their share of the student population, over 6200 additional Black students would be classified as AIG Math" (Ford, Triplett 36).

Recommendations

Match Curriculum to Student Learning Styles so they all stay on the same level

Conclusion

Historically the system of tracking had been set up to punish Black and Brown bodies and in contemporary times it continues to do so. With AP classes being a vital part of any college application the system not only affects them in high school but follows them into higher education.
